Not only do banks and credit unions use this information to determine your creditworthiness, but checking your report is a great way to guard against identity theft.

the only site established to provide free consumer reports as directed by Federal Law.

If you find information that you believe is not correct, contact the company that issued the account or the credit reporting company that issued the report, right away.
